COUNTERTOPS & ISLANDS

“Within Article 210.52(A) (1) of the 2020 NEC, it has been revised to require at least one receptacle within the first nine square feet of an island countertop and an additional receptacle for every 18 square feet more, or fraction thereof.”

AMPERAGE of OUTLET RECEPTACLES

“General-purpose outlets (such as WALL receptacles) should have a rating that is appropriate for the amperage of the circuit they serve. Generally, these household circuits will provide 15-amps or 20-amps of service, and the outlet receptacle rating should not exceed this amperage.”

There is no danger to installing 15-amp outlet receptacles on a 20-amp circuit (in fact, this is the standard practice, especially for supplemental low power accessories and countertop convenience)

“A 20-amp receptacle is generally reserved for locations where a heavy-duty appliance is typically used, such as an outlet that might power a freezer, cooker or washing machine but it is only installed on a 20-amp or larger circuit.”

What is a GFCI Receptacle?

“You can tell if a receptacle is a GFCI one or not by the way it looks.

The GFCI is integrated into an electrical outlet and it typically has a red (or possibly white) reset button on the outlet's faceplate. The outlet monitors how much energy is going into it when in use.



“If the receptacle senses any sort of an electrical overload or imbalance, it is designed to trip the circuit in a fraction of a second.

GFCI receptacles are generally used instead of a standard outlet receptacle to offer protection to single outlet location”.

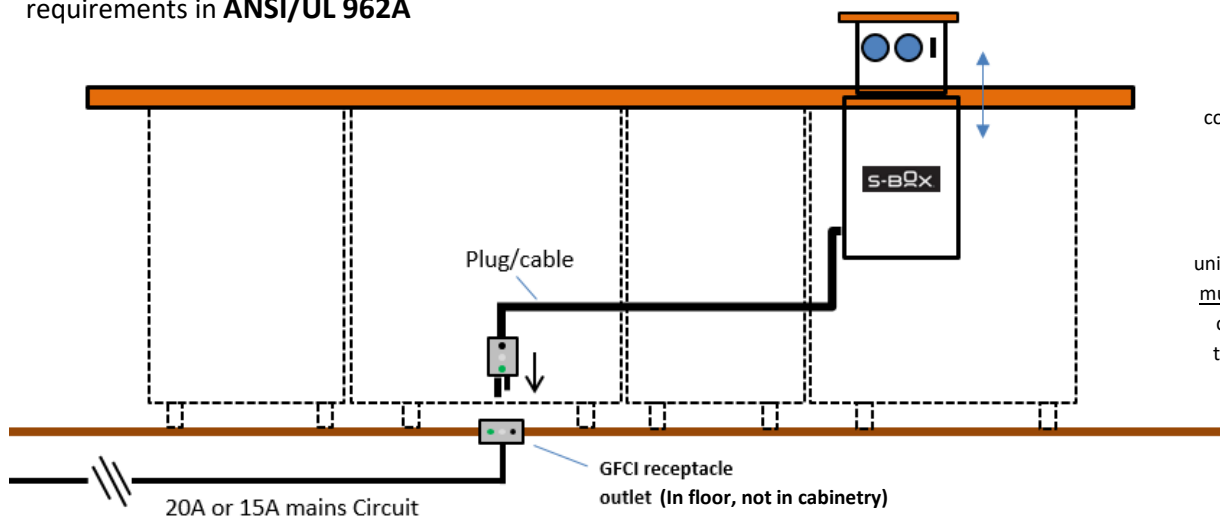
